RA -8750 Seat Belt Law (1999)

Mandates the use of Seat belt in both Private and Public Motor Vehicle

Prohibits to sit a child below 6 years of age in the front seat

RA- 10916 Speed Limiter Act (2016)

Mandates the installation of speed limiter device on trucks, buses And other Public Utility Vehicles



Motor Vehicle Inspection Center - LTO



Inspects all motor vehicles prior to renewal of registration.

Operational: only 4 for the whole country

Moving forward: LTO plans to privatize

Growing Market for Passenger Vehicles



- 52 manufacturers of passenger cars, commercial vehicles and motorcycles in the industry
- 14 of which are car assemblers
- Major Players:

Toyota, Mitsubishi, Honda, Isuzu, and Nissan; one American company – Ford Motors; and one Korean company – Hyundai,

- New Players:
 - BAIC, BYD, Chery, FAW, FOTON, Geely, Great Wall, Haima, JMC, King Long, Lifan, and MG.


Growing Market for Passenger Vehicles

Growing Number of Road Crashes

- 10,012 people died due to road crashes in 2015
- 45.76% increase from 6,869 deaths recorded in 2006.



Advocating for Safer Vehicles (Five Pillars) (



- Congress
- Land Transportation Office
- Department of Transportation (Phil. Road Safety Action Plan)
- CAMPI (Chamber of Automotive Manufacturers of the Phil.)
- Other Road Safety groups and advocates
- Long Term: Legislate a Law that requires all vehicles marketed/sold in the Philippines to have high safety standards
- Short Term: Enjoin regulators to come up with regulation that mandates dealers to indicate safety ratings of vehicles that are on display at their dealerships
